\square Workers in the land, sea and air transport sector or service providers (including drivers of any vehicle for the transportation of goods intended for use on the territory of a Member State as well as those who are only in transit or travelling as a passenger returning to their home base or for training).
Document required: professional card for crews of international goods transport, international passenger transport, international maritime transport.
\square High level professional athlete for participation in meetings validated by the Ministry of Sports.
